AUDITOR

PUBLIQ Software's Tax Management solution provides a flexible approach to vehicle tax calculation and processing. Changes to the vehicle tax roll are simple and taxes and fees can be calculated at any time. A First Time Issue file is sent electronically each week, which helps reduce mistakes and unnecessary data entries.

Our Auditor module helps manage real and other personal property taxes with ease. Maintaining files for all personal property, PUBLIQ imports assessor data then calculates the gross tax and fees before subtracting any exemptions. The module also handles Manufacturers Reimbursement, Fee-In-Lieu of Tax (FILOT), and Homestead applications.

TREASURER/TAX COLLECTOR

PUBLIQ Software's Treasurer/Tax Collector module handles daily tax processing, checks for unpaid taxes, generates refunds, and provides a Daily Collections Report for balancing cash drawers, generating general ledger entries, and printing checks. Barcodes on tax notices speed processing by reducing data entry and errors.
