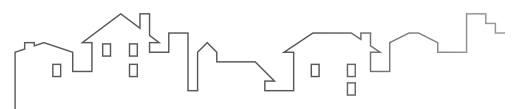


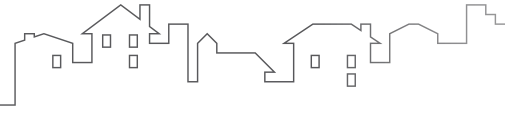
### Tax Collector
